



It is agreed as follows:

'You', 'your' meaning, the Escort

'Client' meaning, those seeking adult entertainment services from Escorts

'We', 'Us' and 'Our' meaning, the operators of DukesofDaisy.com and all associated websites.

'Online Portal' meaning the website intimate-escorts.dukesofdaisy.com and all associated websites.

### **1. Age Restrictions**

- 1.1 You agree that you are of legal adult age (at least 18 years old) to advertise adult entertainment services in the United Kingdom as defined by the U.K laws.
- 1.2 Proof of age may be required; such as photocopy of a driving license or Passport.

### **2. Privacy and Discretion**

- 2.1 We agree not to sell, share or distribute your personal details to any third parties outside of Dukes of Daisy under any circumstances except where it is required by law in accordance with crime prevention or detection.
- 2.2 You agree to notify Dukes of Daisy of any changes to your contact details or any other information that would be required to keep our records relevant.
- 2.3 Our website and services shall not be displayed on any bank statements; to maximise your privacy any payments made by card will show as IT Services or Love 4 IT.
- 2.4 The Escort agrees not to give any contact details to clients acquired from Dukes of Daisy; for management and safety all bookings must go directly through our online portal.
- 2.5 Any Escort found to breach point 2.4 above will immediately be removed from the site without warning.
- 2.6 After registration you may request that your details be removed from our database at any time and with immediate effect. Dukes of Daisy also retains the right to cancel your membership with immediate effect should we deem it necessary and need not provide an explanation.

### **3. Effective Date of Agreement**

- 3.1 This agreement shall come into effect from the date of acceptance of your profile and your agreement to these conditions herein with Dukes of Daisy shall continue until cancellation of membership or your request to remove your details.
- 3.2 This agreement is legally binding and is written in accordance with U.K laws and by advertising an Escort profile on intimate-escorts.DukesofDaisy.com you expressly agree to be bound by them.

### **4. Payments, Renewals & Deposits**

- 4.1 Any fees paid by You in relation to setting up an Escort Profile or Renewing an active Escort profile are strictly non-refundable. This does not affect your statutory rights.

- 4.2 Fees in relation to creating a new Escort Profile may be refunded prior to the profile going live at the discretion of Dukes of Daisy.
- 4.3 Fees/Deposits which are paid by the Client in relation to booking Escorts are strictly non-refundable.
- 4.4 In the event a booking is cancelled by the Escort through no fault of the client; any deposit made by the Client can be used towards rebooking the same or an alternate Escort on our website subject to a formal investigation by Dukes of Daisy.
- 4.5 If the Client refuses to pay the Escort the outstanding sum at the start of the booking, the Escort has a right to immediately and with impunity cancel the booking, and report the Client to Dukes of Daisy who will then blacklist the Client (pending a formal investigation).

## **5. Employment**

- 5.1 Nothing in this agreement creates a partnership, or the relationship of employer and employee between the parties involved.
- 5.2 Any earnings made in respect of bookings from Dukes of Daisy are classed as self-employed earnings.
- 5.3 It is the sole responsibility of the Escort to inform HMRC and pay any taxes due on earnings made in respect of bookings acquired through our online portal. We will never disclose any earnings or booking information to HMRC.

## **6. Escort Profiles**

- 6.1 The Escort agrees to take full responsibility for the content in their profiles; such content in no way reflects the services or products offered by us.
- 6.2 For quality control purposes Escorts are not permitted to login to the website; any changes to Escorts profiles need to be requested by Email and such changes may be rejected where necessary and in accordance with this agreement.
- 6.3 Escorts are not permitted to include direct contact details on their profiles; any Escorts found publishing contact details on their profiles will be removed from the website with immediate effect.
- 6.4 Any and all requests for bookings must go via our Online Portal and will be subject to our usual commissions as agreed between the Escort and Dukes of Daisy.
- 6.5 Dukes of Daisy only provides advertising services and charges a commission to pass on potential Client details to Escorts who will arrange/manage bookings independently.
- 6.6 The Escort agrees that any or all services listed on their profile shall not under any circumstances be offered to anyone under the legal adult age limit.
- 6.7 The Escort agrees that the services offered are wholly and fully legal in the country of which those services are being advertised and do not in anyway breach such laws where applicable.
- 6.8 Dukes of Daisy will promote your Escort profile to Clients via our Online Portal; Clients in turn will contact Us and we in turn will pass on booking/contact details of the Client to the Escort via Email.
- 6.9 The Client agrees that he/she is of legal adult age to view, enquire and purchase services listed on Escort profiles.

6.10 The Client agrees that he/she shall not enquire or attempt to purchase from the Escort any services which are not in line with U.K laws and would otherwise be considered illegal.

## **7. Bookings**

7.1 We at Dukes of Daisy stress that in no way shall we be responsible for any incident in any form whatsoever that may occur with an Escort, Client or both.

7.2 Both the Escort and the Client agree that they are responsible for their own actions at all times before, during and after the completion of a booking.

7.3 It is the responsibility of the Client and Escort to propose/agree a safe and clean place to meet.

7.4 Dukes of Daisy does not guarantee the number and frequency of bookings, this will depend purely on demand and the appeal of the Escorts profile to prospective Clients.

7.5 The Escort agrees not to share any personal contact details with the Client and to instruct the Client where necessary to contact Dukes of Daisy to arrange repeat bookings.

7.6 The Client agrees that future bookings with any/all Escorts listed on Dukes of Daisy must be arranged via our website and/or by email with us. Booking directly with an Escort is strictly prohibited and will result in the Client being banned permanently from our website.

7.7 The Client and Escort agrees that both parties reserve the right to cancel a booking immediately if either party attends a booking in an unfit, unkept or unclean state; this includes intoxication or cold/flu or any contagious conditions/diseases that may be transferrable or pose a health risk.

7.8 The Escort agrees to present herself in a clean and hygienic state/environment, where in-call entertainment is being provided.

7.9 The Client agrees not to share the address of the Escort or turn up without prior arrangement through Dukes of Daisy (where in-call is provided).

## **8. Communication**

8.1 Dukes of Daisy will communicate with Clients and Escorts alike via email. This ensures transparency and allows us to keep an adequate record of correspondence to ensure the safety of Escorts who advertise on our Online Platform.

8.2 All E-mail correspondence is saved securely on encrypted private servers hosted at a secure GDPR compliant data centre in the UK.

8.3 Should any illegal or criminal acts occur including acts of violence against Escorts, Dukes of Daisy will take all necessary actions including passing on Clients or Escorts details to law enforcement agencies.

## **9. Engagements**

9.1 Client and Escort both agree that neither party will, under any circumstances, bring Dukes of Daisy into disrepute and use the website in a method that it was not intended or attempt to access information from the website by unlawful unauthorised means such as manipulating the code i.e. hacking, making use of account credentials that do not belong to you without prior consent of the owner.

9.2 Breaching any of the above points may result in the permanent banning of the Escort or Client from our website and additionally dukes of daisy may take appropriate legal action where necessary in order to recover costs or damages.
